What is a European Citizens' Initiative?

The European Citizens' Initiative (ECI) allows EU citizens to set the political agenda for the EU.

By collecting at least 1 million signatures they may submit a proposal for a legal act that the EU institutions will then be obliged to consider.

While this does not guarantee that the proposed legal act will in the end be adopted, an ECI sends a strong political message both to the EU and to all Member States as to what citizens want them, or don't want them, to do.

In the case of the ECI Mum Dad & Kids, the proposal is to adopt a Regulation that would oblige the EU to recognize that marriage is the union between a man and a woman, and that family relationships are based on marriage and/or descent.

Why should I support Mum Dad & Kids?

Currently there is a trend in many countries that legislators or judges re-define marriage and family, so that these terms may include any group of two or more persons who want to be called by that name.

But in most countries where this has happened, citizens have never been asked their opinion.

Re-defining marriage and family not only widens the scope, but it actually weakens both institutions. If «marriage» and «family» no longer are clearly defined, then both terms lose their meaning. This impacts the efficiency of policies supporting marriage and family, thus undermining the protection of marriage and family.

If there is no clarity on what a family is, then it becomes impossible to make targeted policies that protect and support families.
